# **Administration**

Four Firefighter/Trainees began a two-week in-house academy on April 1, 2024, which will be followed by shift assignments.

California counties, cities and special districts continue watching the development of the State Budget and how to fill the budget deficit. Some language in the Budget Trailer Bill will reallocate our Excess ERAF, which would be a \$500,000 impact to the District revenues.

The Association and Management Groups have requested to open negotiations for our next MOU, which expires as of July 1, 2024. The groups request that the Personnel Committee meet with the representatives of each group and additional information will be provided at the meeting.

### Operations - Chief Ardigo

#### Significant Events:

There were no significant events during the month of March.

#### Out-of-County/Pre-Positioning:

There were no out-of-county/pre-positioning assignments during the month of March.

#### Training - Chief Hellyer

Marin County Block Training focused on Mass Casualty Incidents (MCI) active shooter events. The annual MCI drill took place on the Angel Island ferry. This training included Coast Guard, FBI, State Parks, local fire, and most municipalities that would be involved should this traumatic event occur. Thanks to Captain Elkington for planning and coordinating the training, he put in multiple hours over a period of 4 months planning and coordinating this training.

Our monthly EMS training with Dr. Bason-Mitchell was a mandatory policy and procedure update for all paramedics and EMTs.

In-house EMS training focused on spinal emergencies and treatment.

LT Mark Newman and FF/PM Charles Armour are close to completion of Level 1 Boat Operator and continue to put in the necessary hours. FF/PM Carlos Berlanga has entered the Boat Operator program and started the District task book.

FF Gary Travis has successfully passed the Level 1 daytime hours Boat Operator test and is an operational daytime operator for the District. FF Travis will continue his training in Level 2 nighttime and adverse weather condition operations.

FF/PM Dalton Locke has successfully completed his driver/operator task book, passed the hands on test and is now a signed off District driver/operator.

We have acquired fire hose nozzles from So. Marin Fire and each shift has put in training to gain familiarity with the nozzles and they are now in service.

The new Firefighter-Trainee academy started April 1 and FF/PM Charles Armor is the lead once again.

Personnel with 20 hours or greater of training: Capt. Daniel Elkingtonl (78), FF Gary Travis (34), FF/PM Chris May (44), FF/PM Omar Bell (48) and FF/PM Dalton Locke (26).

Total training hours for March = 422 hours.
